Schedule “A” – Meadowbrook Farms Phase 4

The City of Pewaukee is considering the pavement rehabilitation of Fieldhack Drive. The improvements include road rehabilitation, curb repair, inlet and drainage repair, sanitary manhole repair, water valve repair, and related facilities.

The cost of road improvements and 50% of the curb repairs will be apportioned to all property owners abutting the street with direct or indirect access. The City of Pewaukee caps the road assessments for single-family, duplex residential, and condominium residential properties. All other properties shall pay the full road assessment.

Inlet repairs, 50% of the curb repairs, and drainage improvements will be paid for by the Storm Water Management Utility.

Sanitary sewer repairs will be paid by the Sewer Utility.

Water main repairs will be paid by the Water Utility.

It is recommended the costs for the improvements in Fieldhack Drive be determined on a unit basis.





